- (1) In accordance with Rule 16b-3, shares reported as disposed of were withheld by the Issuer and not issued to the reporting person in order to cover withholding taxes incident to the vesting of restricted stock units.
  - (2) Shares held following the reported transactions include 34,940 restricted stock units, which are subject to forfeiture until they vest.
