This transaction represents the settlement of vested performance stock units in shares of common stock. These were performance stock units granted on 8/23/13 that vested on 7/1/16 and were paid in shares of common stock on 8/26/16. Each performance stock unit represents a contingent right to one share of the Issuer's common stock. The performance stock unit grant was previously reported.

(1) Increase in vested performance stock units granted 8/23/2013 based upon performance stock unit payout formula resulting in an additional payment in shares of common stock on 8/26/16.

(2) Shares withheld by company to pay tax liability on vesting of performance stock units previously awarded.

(3) Of the 27,800 options granted on this 8/26/16 stock option, 9,267 options become exercisable on 8/26/17, an additional 9,267 options become exercisable on 8/26/18, and the remaining 9,266 options become exercisable on 8/26/19.

(4) Each performance stock unit represents a contingent right to one share of the Issuer's common stock. Performance stock units are subject to future adjustment; performance period started 7/2/16. The 4,295 performance stock units will vest on 6/28/19. Vested shares are subject to future adjustment and will be delivered to the reporting person within two and one-half months of vesting.
