 - (2) Non-Qualified Stock Option in respect of shares of common stock granted under the 2017 Performance Plan.
 - (3) The option vests and becomes exercisable in 25% increments over four years commencing one year after the date of grant.
 - (4) Restricted Stock Unit ("RSU") grant under the 2017 Performance Plan of The Goodyear Tire & Rubber Company. The RSUs will vest and convert into shares of Common Stock three years from the date of grant on October 9, 2020.
