These restricted stock units are granted pursuant to the Issuer's 2007 Equity Incentive Plan. Each restricted stock unit represents a (1) contingent right to receive one ordinary share upon the vesting of the unit. These units will vest in three equal annual installments on the anniversary of the grant date, August 9, 2012.

(2) This option is granted pursuant to the Issuer's 2007 Equity Incentive Plan and consists of a nonstatutory stock option exercisable for 8,000 ordinary shares. This option vests over three years from the grant date, August 9, 2012, with 1/3 vesting on the first anniversary of the grant date and the remainder vesting in 24 equal monthly installments thereafter.
