- (1) Shares acquired pursuant to conversion of restricted stock units (RSUs) on a one-for-one basis. RSUs issued pursuant to issuer's Management Stock Purchase Plan under which executive may make an advance election to receive RSUs in lieu of specified percentage or dollar amount of annual incentive cash bonus under bonus plan applicable to executive. RSUs issued on basis of 33% discount to fair market value of issuer's common stock on date underlying bonus otherwise would be paid (\$6.60 in this case) and generally vest 3 years after grant date at which it converts into shares of common stock unless executive has previously elected a longer deferral period. Transactions reported reflect conversion of RSUs originally granted to reporting person on August 9, 1999 into shares and withholding of sufficient shares to pay taxes. Fair market value of shares, based on closing price of issuer's stock on 08/08/05 (last business day before shares vested) is \$25.46.
