(1) Deferred Stock Units granted under the RadioShack 2004 Deferred Stock Unit Plan for non-employee Directors, and includes dividends reinvested in these units. One-third of the units granted vest on each of the first three anniversary dates of the date of grant. All unvested units immediately vest upon occurrence of certain events such as a change in control or a separation from the Board of Directors. Units convert to common stock upon a change in control or thirty (30) days following separation from the Board of Directors.

(2) Under the RadioShack Corporation Unfunded Deferred Compensation Plan (Reg. No. 333-48331), the director received stock units upon deferral of retainer and/or meeting fees, including dividends reinvested in these units.
