(1) At December 31, 2014, the Reporting Person owned 1,049 shares of CCK Common Stock under the CCK 401(k) Plan.

The Reporting Person was granted 17,533 shares of Restricted Common Stock under the 2013 Stock-Based Incentive Compensation Plan. 6,008 shares vest over a three year period as follows: 2,003 shares on January 6, 2016 and January 6, 2017, respectively, and 2,002 shares on January 6, 2018. The final 11,525 shares vest on January 6, 2018 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance based vested shares varying from 0 to 200% of 11,525.
