- (1) Shares were sold pursuant to a 10b5-1 Trading Plan in order to raise funds to pay the required withholding tax pursuant to the vesting of RSUs.
- (2) The average price of \$193.7529 consists of the following blocks of shares: 3,074 at an average price of \$193.67 and 614 shares at an average price of \$194.17.
- (3) On February 21, 2012, the reporting person was granted performance restricted stock units, the vesting of which was subject to both continued service and the degree to which a relative Total Shareholder Return target was attained for the period January 1, 2012 to December 31, 2013. The Compensation Committee certified that the payout for this award would be 136.48% (out of a possible 200%) of the target units granted to the reporting person based on the degree to which Equinix outperformed the Russell 1000 Index.
- (4) Restricted stock unit award expires upon reporting person's termination of employment.
- (5) On February 23, 2011, the reporting person was granted performance restricted stock units, the vesting of which was subject to both continued service and the attainment of certain revenue and EBITDA targets for 2011. These targets were achieved to the maximum

extent, and, therefore, 50% of the award vested on February 22, 2012, with 25% additional units scheduled to vest on each of February 15, 2013 and February 15, 2014, subject solely to continued service.
