(1) On November 13, 2010, the Compensation Committee of the Company's Board of Directors certified that the Company had met the performance criteria established in connection with the 2008 Wright Express Special International Long Term Incentive Program. As a result of achieving the required performance criteria, the reporting person's right to these restricted stock units ("RSUs") was established. The RSUs were originally granted as performance based stock units and converted into RSUs on November 13, 2010.
