 - (4) The phantom stock units were accrued under the Johnson Controls Excess Benefit Plan and are to be settled 100% in cash upon the reporting person's termination of employment.
 - (5) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
