As of the close of business on October 25, 2018, the reporting persons beneficially owned an aggregate of 9,601,652 shares of the Issuer s Common Stock or 8.1% of the Issuer s Common Stock outstanding. The calculation of the foregoing percentage was based on 119,239,673 shares of Common Stock outstanding as of September 4, 2018, as per the Issuer s Form 8-K dated October 23, 2018.

On October 26, 2018, the Issuer was acquired by Conagra Brands, Inc. ("Conagra Brands"). As a result of the merger, the Issuer became a wholly owned subsidiary of Conagra Brands. In connection with the merger, each share of the Issuer s Common Stock issued and outstanding immediately prior to the merger was converted into the right to receive \$43.11 in cash and 0.6494 shares of common stock of Conagra Brands. Accordingly, at the effective time of the merger, the reporting persons no longer beneficially owned any shares of the Issuer s Common Stock.
