State below in reasonable detail why Forms 10-K, 20-F, 11-K, 10-Q, 10-D, N-SAR, N-CSR, or the transition report or portion thereof, could not be filed within the prescribed time period.

On November 2, 2011, the Company and its subsidiaries filed voluntary petitions for relief under Chapter 11 of the U.S. Bankruptcy Code in the United States Bankruptcy Court for the District of Delaware. As a result, the Company has been required to devote a substantial portion of its personnel and administrative resources, including the personnel and resources of its accounting and financial reporting organization, to matters relating to the Chapter 11 filing. Additionally, the Company transitioned from a going concern basis of accounting to a liquidation basis of accounting effective as of October 30, 2011. This transition has required management to devote a significant amount of time and effort to determine the necessary estimates and adjustments to be made to the financial statements under the new basis of accounting. The efforts associated with the Chapter 11 filing and the transition to a liquidation basis of accounting have caused a delay in the ability of the Company to close its books and records, finalize its operating results and prepare its financial statements for the quarter ended November 26, 2011. For these reasons, the Company has not been able to file its Form 10-Q within the prescribed time period. In accordance with Rule 12b-25 under the Securities Exchange Act of 1934, the Company anticipates filing its Form 10-Q no later than five calendar days following the due date.

Due to adverse business conditions, the Chapter 11 filing and other circumstances, there was a significant adverse change in the Company's results of operations for the quarter ended November 26, 2011, as compared to the same fiscal reporting period in the prior year. Additionally, the transition from the going concern basis to the liquidation basis of accounting will cause the presentation of assets and liabilities in the Company's financial statements to differ significantly from prior fiscal reporting periods. For these reasons, the Company is unable to reasonably estimate its results of operations for the quarter ended November 26, 2011.
