- (1) Represents shares of common stock sold pursuant to a 10b5-1 trading plan entered into on August 25, 2015 to satisfy the reporting person's tax obligations upon vesting of 10,833 restricted stock units ("RSUs")
- (2) Weighted average price. These shares were sold in multiple transactions at prices ranging from \$3.19 to \$3.20 inclusive.
