Each Unit represents a contingent right to receive one share of Forum Energy Technologies, Inc. The Units vest according to the following schedule: 1/4 vest on each of the first, second, third and fourth anniversaries of the date of grant (2/20/2017). The Units will be forfeited upon a termination of employment prior to vesting, except in limited circumstances. The credited dividends will be paid concurrently with the issuance of the shares of Common Stock to the reporting person.
