- (1) Each performance-based Restricted Stock Unit ("PRSU") represents a contingent right to receive at settlement one share of Altera common stock at no cost.  
On March 2, 2009, the Reporting Person received a grant of performance-based restricted stock units ("PRSUs"). The PRSUs commenced vesting on July 31, 2010 at a rate of 25% annually. One fourth of the PRSUs vested on July 31, 2013 and shares were delivered to the Reporting Person on that date.
- (2) The grant shall expire ten years from the date of grant.  
On February 19, 2010, the Reporting Person received a grant of performance-based restricted stock units ("PRSUs"). The PRSUs commenced vesting on July 31, 2011 at a rate of 25% annually. One fourth of the PRSUs vested on July 31, 2013 and shares were delivered to the Reporting Person on that date.
- (3) Each Restricted Stock Unit ("RSU") represents a contingent right to receive at settlement one share of Altera common stock at no cost.  
On March 2, 2009, the Reporting Person received a grant of RSUs that vest over a four-year period beginning on July 31, 2010. One fourth of the RSUs vested on July 31, 2013 and shares were delivered to the Reporting Person on that date.
- (4) On February 19, 2010, the Reporting Person received a grant of RSUs that vest over a four-year period beginning on July 31, 2011. One fourth of the RSUs vested on July 31, 2013 and shares were delivered to the Reporting Person on that date.
- (5) On February 25, 2011, the Reporting Person received a grant of RSUs that vest over a four-year period beginning on July 31, 2012. One fourth of the RSUs vested on July 31, 2013 and shares were delivered to the Reporting Person on that date.
