- (1) Of the reported shares, 15,400 shares are represented by performance restricted stock units ("PRSUs") granted on August 25, 2017 and 64,335 shares are represented by PRSUs granted on May 30, 2018, to which the PRSUs have vested based on the Company's achievement of certain performance targets over the last year that were set by the Compensation Committee for the performance period in the first quarters of 2017 and 2018, respectively.
- (2) Of the reported shares 564,857 shares are represented by RSUs.
- (3) The shares reported as disposed of were withheld by the Issuer in order to cover withholding taxes in connection with the vesting of restricted stock units, or RSUs. These shares were not issued to or sold by the Reporting Person.
