*On January 24, 2013, pursuant to an Acquisition Agreement and Plan of Merger by and among, the MamaMancini's Holdings, Inc. (formerly Mascot Properties, Inc., the "Company" or the "Issuer"), Mascot Properties Acquisition Corp., David Dreslin and MamaMancini's, Inc., Matthew Brown was appointed President and was issued 5,154,255 shares of the Company's common stock (the "Shares"). Karen B. Wolf is the wife of Matthew Brown and the Shares are held jointly, however, Matthew Brown maintains full voting control of the Shares.

Item 1 Security and Issuer.

The statement ("Statement") relates to shares of common stock, par value \$0.00001 per share (the "Common Stock"), of MamaMancini's Holdings, Inc., a Nevada corporation (the "Issuer" or the "Company"). The principal executive office of the Issuer is located at 25 Branca Road, East Rutherford, NJ 07073.

Item 2 Identity and Background

The Statement is being filed by Matthew Brown ("Mr. Brown") and Karen B. Wolf ("Ms. Wolf"). Mr. Brown is the President of the Company with an address at 454 Tillou Road, South Orange, New Jersey 07079. Ms. Wolf is the wife of Mr. Brown with an address at 454 Tillou Road, South Orange, New Jersey 07079. Mr. Brown and Ms. Wolf are both United States citizens.

During the last five years neither Mr. Brown nor Ms. Wolf have (i) been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors); or (ii) been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction as a result of which proceeding he was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

Item 3 Source and Amount of Funds or Other Consideration.

Mr. Brown and Ms. Wolf acquired the reported 5,154,255 shares of the Company's common stock as follows:

On January 24, 2013, pursuant to an Acquisition Agreement and Plan of Merger by and among, the Company, Mascot Properties Acquisition Corp., David Dreslin and MamaMancini's, Inc., Mr. Brown was appointed President and was issued 5,154,255 shares of the Company's common stock (the "Shares"). Ms. Wolf is the wife of Mr. Brown and the Shares are held jointly, however, Mr. Brown maintains full voting control of the Shares.

Item 4 Purpose of Transaction.

Neither Mr. Brown nor Ms. Wolf have current plans or proposals which relate to or would result in: (a) the acquisition by either Mr. Brown or Ms. Wolf of additional securities of the Issuer, or the disposition of securities of the Issuer; (b) an extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the Issuer or any of its subsidiaries; (c) a sale or transfer of a material amount of assets of the Issuer or any of its subsidiaries; (d) any change in the present board of directors or management of the Issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board; (e) any material change in the present capitalization or dividend policy of the Issuer; (f) any other material change in the Issuer's business or corporate structure; (g) any change in the Issuer's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the Issuer by any person; (h) causing a class of securities of the Issuer to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association; (i) a class of equity securities of the Issuer becoming eligible for termination of registration pursuant to section 12(g)(4) of the Exchange Act; or (j) any action similar to any of those enumerated above.

Item 5 Interest in Securities of the Issuer.

(a) As of the date hereof, the Mr. Brown and Ms. Wolf have beneficial ownership of the Shares. Such amount represents 24.8% of the total issued and outstanding shares of the Company's common stock as of the date hereof.
(b) Mr. Brown holds sole voting and dispositive power over the Shares as issued to him.
(c) Other than disclosed below, there were no transactions by either Mr. Brown or Ms. Wolf in the Issuer's Common Stock during the last 60 days:
