ESP is the record holder of the Common Units of the Issuer ("Units") reported in this line on this Form 4 and has a direct pecuniary interest in the Units. ESSC, ESLLC, and ESCLP beneficially own the Units for the purposes of Section 13(d) of the Exchange Act and have an indirect pecuniary interest in the Units.
 - (1) On August 17, 2016, ESP sold 400,171 Units on the New York Stock Exchange in open market sales, at prices ranging from \$12.050 to \$12.205 per Unit, with a weighted-average per-Unit price of \$12.0939.
 - (2) On August 18, 2016, ESP sold 527,547 Units on the New York Stock Exchange in open market sales, at prices ranging from \$12.05 to \$12.35 per Unit, with a weighted-average per-Unit price of \$12.1125.
