in the applicable account(s) with another unaffiliated entity. The issuer's securities

held in any such account(s) are less than 5% of the outstanding shares of the class. In

addition, FRI does not believe that any such contract causes such client or unaffiliated

entity to be part of a group with FRI or any FRI affiliate within the meaning of Rule 13d 5

under the Act.
