On May 20, 2014, the reporting person exercised 10,000 stock options, delivered 3,769 shares of Common Stock of the Company for cancellation in payment of the exercise price of such options, and had 3,213 shares of Common Stock of the Company withheld and cancelled to cover minimum required tax withholding. These shares cancellations are shown on Table I as dispositions (Transaction Code "D" in column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in column 3.
