On February 24, 2005, the Compensation Committee (the "Compensation Committee") of the Board of Directors of GP Strategies Corporation (the "Company") authorized the payment of bonus awards of \$350,000 to Scott Greenberg, the Company's President and Chief Financial Officer, and \$50,000 to Andrea Kantor, the Company's Vice President and General Counsel, in respect of the year ended December 31, 2004.
