Spindletop Oil & Gas Co. is unable to file its quarterly report on Form 10-Q for the period ended March 31, 2015 without unreasonable effort and expense due to the late receipt of information required from purchasers of oil and gas and from third party operators.

Net income for the period ended March 31, 2015 is anticipated to decrease as compared with the same period in 2014. In 2014 we reported net income of \$1,015,000; however we anticipate reporting a net loss for the period ended March 31, 2015, that will be in the range of approximately \$100,000 - \$200,000, or a loss of \$0.01 - \$0.03 per share.

Total revenues for the first quarter of 2015 are anticipated to be \$1,456,000 as compared to the \$3,568,000 that was reported in 2014, a decrease of approximately \$2,112,000 or 59.19%. The primary decline in revenues is due to a decrease in oil and gas prices between the two periods. Average oil prices declined from \$113.76 per bbl in 2014 to \$46.33 per bbl in 2015, a 59.28% decrease. Average natural gas prices declined from \$4.64 in 2014 per mcf to \$2.67 per mcf in 2015, a 42.46% decrease. In addition to the decreases in prices between the two periods, production of oil and gas declined by 20.57% and 6.52% respectively.

Total expenses for the period ended March 31, 2015 are expected to decrease by approximately \$150,000 over total expenses previously reported for the first quarter of 2014.
