Net loss for the nine month period ended September 30, 2016 is anticipated to decrease as compared with the same period in 2015. In the nine month period ended September 30, 2015 we reported a net loss of \$587,000 or \$0.08 per share; however we anticipate that for the period ended September 30, 2016, net loss will be in the range of approximately \$315,000 - \$325,000, or a loss of approximately \$0.05 per share.

Reported total revenues for the nine months ended September 30, 2016, are expected to decrease approximately \$1,165,000 over that reported for the same period of 2015. This decrease in revenue is primarily due to a combination of decreases in oil and natural gas prices as well as decreases in production.

Total expenses for the nine months ended September 30, 2016, are expected to decrease by approximately \$1,870,000 over that reported for the same period in 2015.
