ITEM 1.01 - ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT

On December 1, 2004, Chesapeake Energy Corporation entered into a Purchase Agreement with Deutsche Bank Securities Inc., Banc of America Securities LLC, Credit Suisse First Boston LLC, Lehman Brothers Inc. and UBS Securities LLC as representatives of the Several Purchasers to sell to the Purchasers \$600 million principal amount of the Company's 6.375% Senior Notes due 2015. The senior notes are to be issued under an indenture dated as of December 8, 2004. A copy of the press release announcing the pricing of the 6.375% senior notes due 2015 is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
