Pursuant to investment management agreements, each of SAC Capital Advisors and SAC Capital Management share all investment and voting power with respect to the securities held by SAC Capital Associates. Pursuant to an investment management agreement, Walter Management maintains investment and voting power with respect to the securities held by Global Investments. Mr. Cohen controls each of SAC Capital Advisors, SAC Capital Management and indirectly owns a 49% interest in the managing member of Walter Management. By reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) SAC Capital Advisors, SAC Capital Management and Mr. Cohen may be deemed to own beneficially 1,275,000 Shares (constituting approximately 1.5% of the Shares outstanding) and (ii) Walter Management and Mr. Cohen may be deemed to own beneficially 179,666 Shares (constituting approximately 0.2% of the Shares outstanding).
