- (1) The reporting person had 4,000 shares vest since the last filing.
- (2) Restricted Stock granted on August 24, 2015 will vest in 33 1/3% installments over five years beginning on the third anniversary of the award date.
- (3) Restricted Stock granted on January 18, 2013 will "cliff" vest 100% three years from award date.
