(1) Term Preferred Shares of NKG for an equal number of newly issued Variable Rate MuniFund Term Preferred Shares, Series 2019, of NKG, and purchased 70 newly issued Variable Rate MuniFund Term Preferred Shares, Series 2019, of NKG, for a purchase price of \$100,000 per share.

(2) This statement is jointly filed by Wells Fargo & Company and Capital Strategies. Wells Fargo & Company holds an indirect interest in the securities listed in Table I (the "Securities") by virtue of its indirect ownership of its subsidiary Capital Strategies.
