Endowment Capital Group, LLC, a Delaware limited liability company ("Endowment LLC"), is the sole general partner of the Limited Partnership. Mr. Philip C. Timon (the "Reporting Person") is the sole managing member of Endowment LLC. As a result, the Reporting Person possesses the sole power to vote and the sole power to direct the disposition of the Shares held by the Limited Partnership. Thus, as of the Reporting Date, for the purposes of Reg. Section 240.13(d)-3, the Reporting Person is deemed to be the beneficial owner of 2,249,166 Shares, or approximately 5.4%, of the Shares deemed issued and outstanding as of such date.
