#### **Explanatory Note**

On September 25, 2013, the Registrant filed Form 8-K disclosing entry into a material definitive agreement. The table disclosed in Item 1.01 of such Form 8-K contained typographical errors in the column under the heading "Estimated Closing Period." Specifically, the "Estimated Closing Period" for each of Lofts at Weston, St. Mary's Square and The Apartments at Blakeney should have been estimated as "Q4 2013" rather than "Q3 2013." Additionally, Exhibit 2.1 contained a typographical error that noted the date of the Agreement as September 10, 2013, whereas the actual date of the agreement was September 12, 2013. The Registrant hereby amends such Form 8-K to correct the typographical errors. The full text of such Form 8-K, as amended to correct such typographical errors, is set forth in this Amendment No. 1 to Form 8-K.

ITEM 1.01 Entry into a Material Definitive Agreement.

On September 20, 2013, Associated Estates Realty Corporation (the "Company") entered into an Agreement of Purchase and Sale ("Agreement") with entities controlled by Northwood Ravin, LLC (the "Sellers") to acquire seven properties (the "Portfolio"), as identified in the table below, for total cash consideration of approximately \$323.9 million, less the assumption of \$28.0 million of existing mortgage financing. The Company expects to acquire each of the properties based on the closing periods set forth in the table below. The closing of The Apartments of Blakeney is also contingent upon the assumption of an existing \$28.0 million mortgage loan. The closing of Alpha Mill Phase I and Alpha Mill Phase II is contingent on the completed construction of Alpha Mill Phase II. The closing of each of Perimeter Town Center and Varela is contingent upon the completed construction of each such property. The table below provides details for each property the Company plans to acquire:

The Company's obligation to purchase the Portfolio is subject to certain closing conditions specified in the Agreement and that certain Second Amendment to the Agreement (the "Amendment"). Although the Company intends to acquire the entire Portfolio, and regards its acquisition of each property in the Portfolio as probable, there can be no assurance that the Company will acquire such properties.

A copy of the Agreement is attached hereto as Exhibit 2.1, and a copy of the Amendment is attached hereto as Exhibit 2.2. Each of the Agreement and the Amendment is incorporated herein by reference. The foregoing description of the Agreement and the Amendment does not purport to be complete, and is qualified in its entirety by reference to the full text of the Agreement and the Amendment.
