The following constitutes Amendment No. 3 to Schedule 13D filed by the undersigned (the "Amendment No. 3"). This Amendment No. 3 amends the Schedule 13D as specifically set forth herein.

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 is hereby amended and restated to read as follows:

The Shares purchased by each of Vertex Opportunities and VSO II were purchased with working capital (which may, at any given time, include margin loans made by brokerage firms in the ordinary course of business) in open market purchases, except as otherwise noted, as set forth in Schedule A, which is incorporated by reference herein. The aggregate purchase price of the 910,534 Shares beneficially owned by Vertex Opportunities is approximately \$2,355,437, excluding brokerage commissions. The aggregate purchase price of the 901,234 Shares beneficially owned by VSO II is approximately \$2,074,148, excluding brokerage commissions.
