Submission of Matters to a Vote of Security Holders.

On April 7, 2016, Biglari Holdings Inc. (the “Company”) held its Annual Meeting of Shareholders (the “Meeting”). The total number of shares of the Company’s common stock voted in person or by proxy at the Meeting was 1,998,836, representing approximately 96.70% of the 2,066,864 shares outstanding and entitled to vote at the Meeting. The matters voted on by shareholders and the number of votes cast for, against or withheld, as well as abstentions and broker non-votes, if applicable, with respect to each matter is set forth below.

Proposal 1. To elect the nominees listed below as directors of the Company:

William L. Johnson retired from the Board of Directors at the Meeting, and the authorized number of directors was reduced to five upon his retirement.
