Accordingly, on June 24, 2004, the option became exercisable for 37,500 shares at an exercise price of \$24.93 per share. The option was further adjusted to reflect WCI's 3-for-2 stock split in the form of a 50% stock dividend effective March 13, 2007. Accordingly, on March 13, 2007, the option became exercisable for 56,250 shares at an exercise price of \$16.62 per share.
