- (1) This grant has two distinct vesting provisions. One-fourth of 24,579 shares will vest on each of the first four anniversaries of the date of grant. The remaining 55,000 shares will vest four years from the date of grant, except that the vesting of one-fourth of the 55,000 shares may be accelerated on each of the first, second and third anniversaries of the date of grant if StorageTek meets predetermined performance criteria, set by the Human Resources and Compensation Committee of the Board of Directors.
