- (1) On March 5, 2007, the Partnership converted 116,800 shares of Class B Common Stock into shares of Class A Common Stock on a one-for-one basis for no cost; accordingly, there was no applicable purchase or sale (63,208 shares represents Mr. Tyson's pro-rata interest).
  - (2) On March 6, 2007, the Partnership converted 136,600 shares of Class B Common Stock into shares of Class A Common Stock on a one-for-one basis for no cost; accordingly, there was no applicable purchase or sale (73,923 shares represents Mr. Tyson's pro-rata interest).
  - (3) On March 7, 2007, the Partnership converted 561,000 shares of Class B Common Stock into shares of Class A Common Stock on a one-for-one basis for no cost; accordingly, there was no applicable purchase or sale (303,594 shares represents Mr. Tyson's pro-rata interest).
