**Item 8.01. Other Matters**

Magellan Health, Inc. (the Company ) had a contract with the Louisiana Department of Health and Hospitals (the Louisiana Department ) to manage behavioral health care for Medicaid recipients and other beneficiaries through the Louisiana Behavioral Health Partnership (the Current Contract ). The Current Contract, which generated annual revenue of approximately \$150 million, expired on February 28, 2015. On March 2, 2015, the Company and the Louisiana Department entered into a new emergency contract with terms through November 30, 2015. The emergency contract will cover services substantially the same as the Current Contract. As previously disclosed, the Louisiana Department informed the Company that effective December 1, 2015, behavioral health care management and other services to Medicaid and other beneficiaries will be transitioned to general Medicaid managed care plans in Louisiana.
