- (a) Mr. Robotti may be deemed to have beneficial ownership of 732,597 shares of the Common Stock through the following:
- his ownership of Robotti & Company by virtue of the investment discretion Robotti & Company has over its discretionary brokerage customers, which beneficially holds an aggregate of 5,940 shares of the Common Stock; and
 - his ownership of Robotti Advisors, an investment adviser in accordance with Rule 13d-1(b)(1)(ii)(E), by virtue of the investment discretion Robotti Advisors

has over the accounts of its advisory clients, which beneficially holds an aggregate of 321,600 shares of the Common Stock; and

- his position as Managing Member of RMC, which serves as the General Partner of RIC. RIC beneficially owns 405,057 shares of the Common Stock.

- (b) The amount of 732,597 shares of the Common Stock beneficially owned by Mr. Robotti is 8.2% of the total outstanding shares of 8,919,153 Common Stock, no par value per share, as of December 31, 2004, as per the Issuer's most recent 10-Q/A dated January 14, 2005.
- (c) (i) Mr. Robotti does not have the sole power to vote or direct the vote of any shares of the Common Stock.
(ii) Mr. Robotti shares the power to vote or direct the vote of 732,597 shares of the Common Stock through the following:
- he shares with Robotti & Company and its discretionary brokerage customers the power to vote or direct the vote of 5,940 shares of the Common Stock; and
 - he shares with Robotti Advisors and its advisory clients, the power to vote or direct the vote of 321,600 shares of the Common Stock; and
 - he shares with the other Managing Member of RMC, which serves as the General Partner of RIC, the power to vote or to direct the vote of 405,057 shares of the Common Stock.
- (iii) Mr. Robotti does not have sole power to dispose or to direct the disposition of any shares of the Common Stock.
(iv) Mr. Robotti shares the power to dispose or to direct the disposition of 732,597 shares of the Common Stock through the following:
- he shares with Robotti & Company and its discretionary brokerage customers the power to dispose or direct the disposition of 5,940 shares of the Common Stock; and
 - he shares with Robotti Advisors and its advisory clients, the power to dispose or direct the disposition of 321,600 shares of the Common Stock; and
 - he shares with the other Managing Member of RMC, which serves as the General Partner of RIC, the power to vote or to direct the vote of 405,057 shares of the Common Stock.
