The award was disclosed in the table on page 35 of BlackRock's 2015 Proxy Statement in the column headed "Long-Term Incentive Award (BPIP)". As outlined in BlackRock's 2015 Proxy Statement, the award was subject to adjustment based on certain performance metrics approved by the Management Development and Compensation Committee at the time of the award. Based on the Company's performance, the Restricted Stock Units vesting represent 109.5% of original award.
