All shares of the Issuer's Class A common stock were valued at the closing price on December 31, 2015.

The shares of Phantom Stock become payable in a single distribution of shares of Common Stock, at such time as elected by the Reporting Person at the time such deferral was made pursuant to Section 3.4 of the Pzena Investment Management, Inc. Non-Employee Director Deferred Compensation Plan (previously filed as Exhibit 10.1 to the Issuer's quarterly report on Form 10-Q, filed with the Securities and Exchange Commission on November 9, 2009).
- (3) Includes an aggregate of 3,190 shares of Phantom Stock issued in-kind as dividend payment.
