Montalbano and Boyle are owners of the General Partner, the Investment Manager and the Broker-Dealer, and have discretionary investment authority over the assets of the Fund and the Accounts. The General Partner, the Investment Manager, the Broker-Dealer and Messrs. Montalbano and Boyle may be deemed to beneficially own the shares owned directly by the Fund and the Accounts. Each Reporting Person disclaims beneficial ownership with respect to any shares other than those owned directly by such Reporting Person.
