**Item 5.07 Submission of Matters to a Vote of Securities Holders.**

The Company’s Annual Shareholders Meeting (“Meeting”) was held on June 21, 2016. There were present in person or by proxy at said Meeting shareholders voting 4,953,657 shares that represent 92.34% of the 5,364,647 shares outstanding and entitled to vote at the Meeting which represented a quorum. At the Meeting, the shareholders:

1) Voted on the Election of Directors as follows:

All seven individuals were elected to serve on the Board of Directors for the following year.

2) Voted on our Executive Compensation. There were 2,431,178 votes for, 443,576 votes against, 24,560 votes abstained, and 2,054,343 broker non-votes. The votes ‘for’ constituted a majority of those voting in person or by proxy, and also represented at least a majority of the voting power required to constitute a quorum at the Annual Meeting.

3) Voted on the ratification of Moss Adams LLP as the Company’s Independent Registered Public Accounting Firm. There were 4,521,031 votes for, 406,852 votes against, 25,774 votes abstained, and 0 broker non-votes. The votes ‘for’ constituted a majority of those voting in person or by proxy, and also represented at least a majority of the voting power required to constitute a quorum at the Annual Meeting.
