- (c) Mr. Lewis a businessman and was appointed as President, Treasurer, Secretary and director of Lithium Corporation on August 25, 2009.
- (d) Mr. Lewis has not been convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors) during the last five years.
- (e) Mr. Lewis has not been a party to any civil proceeding of a judicial or administrative body of competent jurisdiction where, as a result of such proceeding, there was or is a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.
- (f) Mr. Lewis is a citizen of the United States of America.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATIONS

On October 23, 2009, Mr. Lewis acquired 10,000,000 common shares pursuant to a transfer of shares from Mr. Mazen Hleiss.

ITEM 4. PURPOSE OF TRANSACTION

The purpose of the transaction described above was for investment purposes.

Depending on market conditions and other factors, Mr. Lewis may acquire additional shares of the Issuer's common stock as he deems appropriate, whether in open market purchases, privately negotiated transactions or otherwise. Mr. Lewis also reserves the right to dispose of some or all of the Shares in the open market, in privately negotiated transactions to third parties or otherwise.
