- (1) Grant date, 4 year vesting, 25% on first anniversary of grant date, then 6.25% vests quarterly over the remaining 12 quarters. The vesting accelerated and became 100% vested on December 25, 2005.

- (3) Includes time-based and performance-based (now deemed earned) restricted shares awarded on April 25, 2006, April 27, 2007, and February 19, 2008. 13,182 shares vest on January 1, 2009, 8,195 vest on January 1, 2010, and 4,166 vest on January 1, 2011.
