Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities in column 5 includes 2.7165 vested dividend equivalent rights at \$42.26 per RSU credited to the reporting person's account on 12/30/10, and a de minimus adjustment of 0.7579 due to fractional rounding of the dividend equivalent rights.

The number of derivative securities beneficially owned in column 9 includes 5.3649 dividend equivalent rights at \$42.26 per RSU credited to the reporting person's account on 12/30/10.
