A total of 20,000 restricted stock units were originally awarded on March 24, 2008 of which 5,000 units have vested and converted into an equal number of shares of common stock.. Pursuant to the terms of the Executive Officers' Change of Control Incentive and Severance

- (5) Benefit Plan, as amended, 5,000 units vested and shares became issuable on July 10, 2009 upon a change of control. The remaining units shall vest and shares become issuable in two equal annual installments beginning on March 24, 2010.

A total of 100,000 restricted stock units were originally awarded on March 20, 2009. Pursuant to the terms of the Executive Officers' Change of Control Incentive and Severance Benefit Plan, as amended, 33,330 units vested and shares became issuable on July 10, 2009

- (6) upon a change of control. The remaining units shall vest and shares become issuable in two equal annual installments beginning on March 20, 2010.

As of July 10, 2009, the reporting person owned approximately 9,097 units, which units represent interests in a Wind River 401(k) Plan.
