- (1) On September 15, 2009, the Reporting Person received a grant of restricted stock units ("RSUs") covering 5,000 shares of KLA-Tencor common stock. On September 15, 2013, the Reporting Person vested in fifty percent (50%) of such RSUs.
 Pursuant to the terms of the September 15, 2009 RSU grant, 940 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. Because the vesting date of such RSUs occurred on a day on which the NASDAQ Stock Market was closed for trading, the fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on the last completed trading day immediately prior to such vesting date.
- (3) This transaction was effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on June 14, 2013.
