Independent directors receive an annual grant of restricted stock each calendar year, in an amount equal to \$75,000 divided by the closing price of the Company's stock on the day prior to issuance. Vesting will be accelerated in the event of a change in control, death or disability of Mr. Bynoe or in the event Mr. Bynoe is not re-elected to the Board or is not nominated for election to the Board by the Company after indicating a willingness to serve.

On October 15, 2013, the Company effected a one-for-ten reverse split of its common stock (the "Reverse Split"), as reported
