The Registrant's Form 10-Q has not been completed by the due date because the Registrant requires additional time to finalize its unaudited financial statements for the Quarter ended March, 31, 2006. The Registrant issued a press release on May 8, 2006 announcing its third quarter updated preliminary results which was furnished to the Securities and Exchange Commission as an exhibit under Item 2.02 of Form 8-K on May 8, 2006. The Registrant expects that it will file the Form 10-Q as soon as practicable and that the financial statements included in such filing will reflect any potential adjustments that may be required as the result of an asset impairment evaluation as well as any other necessary adjustments and/or disclosures that must be included in order for such financial statements to be stated in accordance with U.S. generally accepted accounting principles.

On May 8, 2006, the Registrant issued a press release reporting its adjusted preliminary financial results for the quarter ended March 31, 2006. As disclosed in that press release, which was furnished to the Securities and Exchange Commission as an exhibit under Item 2.02 of Form 8-K on May 8, 2006, the Registrant reported net loss for the quarter ended March 31, 2006 of \$43 million, compared to net loss of \$45 million for the quarter ended March 25, 2005.

The Registrant also reported revenue for the quarter ended March 31, 2006 of \$108 million, compared to revenue of \$159 million for the quarter ended March 25, 2005. As described in the Registrant's press release, the financial information presented in the press release is subject to adjustment based on the results of the asset impairment evaluation as discussed in Part III above.

Factors that might cause such a difference in results include, but are not limited to: the effects of our chapter 11 filing; our ability to maintain adequate liquidity; our ability to obtain and maintain normal terms with customers, suppliers and service providers; our ability to continue as a going concern; our ability to operate pursuant to the terms of our credit agreement; our ability to obtain Bankruptcy Court approval and any other required approvals with respect to motions in the chapter 11 case prosecuted by us from time to time; our ability to develop, prosecute, confirm and consummate one or more plans of reorganization with respect to our chapter 11 case; risks associated with third parties seeking and obtaining Bankruptcy Court approval to either terminate or shorten the exclusivity period that we have to propose and confirm one or more plans of reorganization; risks associated with third parties seeking and obtaining Bankruptcy Court approval to appoint a chapter 11 trustee; risks associated with third parties seeking and obtaining bankruptcy court approval to convert the chapter 11 filing to a chapter 7 filing; our ability to maintain contracts that are critical to our operation; our ability to conclude our exploration of strategic alternatives; risks associated with the volatility of our stock price; risks associated with the timely development, production and acceptance of new products and services; increased competition; dependence on third party partners and suppliers; the failure to achieve expected product mix and revenue levels; failure to manage costs and generate improved operating results and cash flows; failure to maintain compliance with debt covenants; and failure to maintain adequate cash resources for the operation of the business. Additionally, due to material uncertainties, it is not possible to predict the length of time we will operate under chapter 11 protection, the outcome of the proceeding in general, whether we will continue to operate under our current organizational structure, or the effect of the proceeding on our businesses and the interests of various creditors and security holders.
