Item 4. Ownership.

(a) Amount beneficially owned:

QVT Financial LP (QVT Financial) is the investment manager for QVT Fund LP (the Fund), which beneficially owns an aggregate of 4,728,370 Common Shares, consisting of 3,201,617 Common Shares and an additional 1,526,753 Common Shares underlying common share purchase warrants (Warrants), and for Quintessence Fund L.P. (Quintessence), which beneficially owns an aggregate of 515,447 Common Shares, consisting of 349,343 Common Shares and an additional 166,104 Common Shares underlying Warrants. QVT Financial is also the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account), which holds 108,865 Common Shares. QVT Financial has the power to direct the vote and disposition of the Common Shares held by each of the Fund, Quintessence and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 5,352,682 Common Shares, consisting of the shares owned by the Fund and Quintessence and the shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of Common Shares reported by QVT Financial. QVT Associates GP LLC, as General Partner of the Fund and Quintessence, may be deemed to beneficially own the same number of Common Shares reported by the Fund and Quintessence, and accordingly may be deemed to beneficially own 5,243,817 Common Shares.

Each of QVT Financial and QVT Financial GP LLC disclaim beneficial ownership of the Common Shares owned by the Fund and Quintessence and held in the Separate Account. QVT Associates GP LLC disclaims beneficial ownership of the shares owned by the Fund and Quintessence, except to the extent of its pecuniary interest therein.

The approximate percentage of Common Shares reported beneficially owned by each reporting person herein is based upon the sum of (i) 59,284,528 Common Shares issued and outstanding, as reported in the Issuer's Report on Form 6-K filed with the Securities and Exchange Commission on November 30, 2007, and (ii) the number of shares of Common Stock issuable upon exercise of the Warrants held by such reporting person.
