Ampio Lock-up Extensions

Dr. David Bar-Or, Ampio s founder and chief scientific officer, and Michael Macaluso, Ampio s chief executive officer and chairman, have agreed to extend lock-up restrictions regarding their sale or other disposition of shares of Ampio common stock to January 1, 2013, subject to certain exceptions, including limited sales (up to 429,400 shares of common stock collectively) in connection with publicly registered offerings.
