# Item 8.01. Other Events.

On February 22, 2016, Carnival Corporation (the Company ) completed its offering of 500,000,000 million aggregate principal amount of senior unsecured 1.625% notes due 2021 (the Notes ). The Notes are guaranteed by Carnival plc, a company incorporated and registered under the laws of England and Wales (the Guarantor ). The Company intends to use the net proceeds from this offering for general corporate purposes.

The offering of the Notes was registered under the Securities Act of 1933, as amended, pursuant to a registration statement on Form S-3 (File Nos. 333-202619 and 333-202619-01) (the Registration Statement ) filed with the Securities and Exchange Commission (the Commission ) on March 9, 2015. The terms of the Notes are described in the Company s Prospectus dated March 9, 2015, as supplemented by a final Prospectus Supplement dated February 15, 2016, as filed with the Commission on February 17, 2016.

In connection with the offering, on February 15, 2016, the Company and the Guarantor entered into an Underwriting Agreement (the Underwriting Agreement ) with the underwriters listed in Schedule I thereto (collectively, the Underwriters ). The Underwriting Agreement contains customary representations, covenants and indemnification provisions. A copy of the Underwriting Agreement is attached as Exhibit 1.1 to this Current Report on Form 8-K and is incorporated by reference into the Registration Statement.

The Notes were issued pursuant to an Indenture, dated as of November 6, 2015, by and among the Company, the Guarantor and U.S. Bank National Association (the Trustee ), as trustee, as amended and supplemented by the Second Supplemental Indenture, dated February 22, 2016, by and among the Company, the Guarantor and the Trustee, as trustee. The Second Supplemental Indenture is attached hereto as Exhibit 4.1 and is incorporated by reference into the Registration Statement.

The Notes will mature on February 22, 2021 and will bear interest at a rate of 1.625% per year. Interest on the Notes will be payable annually in arrears on February 22 of each year, commencing on February 22, 2017. The Notes are unsecured senior obligations of the Company and rank equally with its other unsecured and unsubordinated obligations. The guarantees of the Notes are unsecured senior obligations of the Guarantor and rank equally in right of payment with all other unsecured and unsubordinated obligations of the Guarantor. The form of the Note is attached as Exhibit 4.2 to this Report and is incorporated by reference into the Registration Statement.

The legality opinions of Paul, Weiss, Rifkind, Wharton & Garrison, LLP, Freshfields, Bruckhaus Deringer LLP and Tapia, Linares y Alfaro are attached hereto as Exhibits 5.1, 5.2 and 5.3, respectively, and are incorporated by reference into the Registration Statement.
